You may exhibit, exploit, advertise and translate the Location Footage and the Production throughout the universe in perpetuity in and by any and all languages, means, and forms of media now or in the future discovered, including sequels, prequels, remakes, serials, adaptations and all ancillary and subsidiary rights thereto, (including without limitation, linear and non-linear CD-Rom, CDI, Internet, electronic publishing and other interactive media products). You may freely use, adapt, revise, add to, edit and subtract from the Location Footage and the Production. You may assign, license, transfer or otherwise dispose of any of these rights in whole or in part without notice of further consent being required. The undersigned acknowledges that Producer is the sole and exclusive copyright owner of the Location Footage.

The undersigned waives and relinquish all rights and remedies at law or in equity, including moral rights, and releases and forever discharges you and all others dealing with you from, and agree not to sue you or any of them, with respect to any claim, cause of action, liability, loss or damage of any nature whatsoever arising out of your exercise of rights granted herein, including claims relating to defamation or invasion of any right of copyright, privacy, personality or publicity.

The undersigned agrees that no additional compensation shall be payable with respect to the Production and use of the Location Footage other than the consideration set out above.

The Undersigned represent and warrants that he/she/it has the right and authority to make and enter into this Agreement and to grant to Producer the rights set forth herein, without the obtaining of any consents or permissions from anyone.

The undersigned has read and understood this Agreement prior to signing and is fully familiar with all terms herein.
